

Minutes of the meeting of the Study and Evaluation Commission for the granting of three "Our Many Europes" research residencies at the Study Center of the Museo Nacional Centro de Arte Reina Sofía

In Madrid, September 1, 2020, at 4:00 p.m., it is established the Study and Evaluation Commission provided in the section 6.1. of the Call for Three "Our Many Europes" research residencies in the Study Center of the Museo Nacional Centro de Arte Reina Sofía during the period 2020-2021.

In accordance with the provisions of section 6.3. of the aforementioned call, the Study and Evaluation Commission is chaired by Ana Longoni, Director of Public Activities of the MNCARS and made up of the following members:

- Jesús Carrillo, coordinator of the force line "Radical action and Imagination" in MNCARS' Study Centre
- Sara Buraya Boned, project manager of Our Many Europes L'Internationale
- Mabel Tapia, member of the Editorial Board of L'Internationale Online

A total of 112 applications have been submitted to the call object of study and evaluation by the Commission.

In relation with the scoring of the applications, the Commission appreciates the significant participation of more than a hundred research projects in this call, many of them of excellent value and relevance, and submitted from diverse parts of Europe and Latin America, which points out the importance and need to sustain and expand calls such as this one.

The assessment criteria have been governed, according to the scoring system established in base 6.2. of the aforementioned call:

- a) The professional background of the applicant, in line with that stated in Term 1.a. of the present Call, and with a maximum score of four (4) points. In the case of a joint candidacy, the scoring in this section will be an average of the assessments obtained from the professional background of each member of the collective.
- b) The research project to be developed during the Residency, in accordance with that stated in Term 2.b. of the present Call, and with a maximum score of (6) points.

The Commission agrees to evaluate the research projects considering their thematic concepts, relevance and originality of the research; the feasibility of its work plan as well as its articulation with the resources provided by the MNCARS; and the potential synergy with the project "Our Many Europes".

The Commission has considered and assessed in detail the documentation provided by the applicants, in accordance with the aforementioned criteria and scores.

Considering the results of this assessment, the Commission agrees to announce the following score report in order to grant the research residencies.
